Essential:

Four years integrated degree course from NCTE recognized Institution/University with at least 50% marks in the concerned subject(s) as well as in the aggregate.

OR

Bachelor/Honours Degree from a recognized Institution/University with at least 50% marks in concerned subject, combination of subjects as well as in the aggregate

OR

Post-Graduation in concerned subject/any specialization in concerned subject with a minimum 55% marks or equivalent grade provided that the candidate has studied the subject(s) mentioned in the note below at the graduation level.

NOTE:.

- a) For TGT (Gujrati): Studied Gujrati as an Elective/Main subject in at least 03 years/ 06 semester of the course.

Desirable Qualification:

- (i) B.Ed. Degree from NCTE recognized institution/University with at least 50% marks

OR

Three years Integrated B.Ed.-M.Ed. from NCTE recognized Institution/ University with at least 50% marks

OR

1- year B.Ed. (Special Education) from Rehabilitation Council of India (RCI) with at least 50% marks.

AND

- (ii) Qualified in the Central Teachers Eligibility Test (Paper-II) conducted by Central Board of Secondary Education (CBSE)

- (i) Experience of working in a school

- (ii) Knowledge of Computer applications.

- (iii) Working knowledge of English and Hindi/Bhartiya Bhasha.

Note :- B.Ed. or Three years Integrated B.Ed.-M.Ed. and CTET qualified candidates will be preferred

Qualification for TGT (P & HE):

Essential: Four year integrated course/Bachelor's Degree in Physical Education/Bachelor of Physical Education and Sports offered by NCTE recognized Institution/University with at least 50% marks **OR** Graduation from a recognized university and B.P.Ed offered by NCTE recognized institution/University with at least 50% marks in Graduation and B.P.Ed separately.

Desirable: (i) Represented at least State at National level in any of the Sports/Games recognized by Sports Authority of India (SAI)/the concerned federation (ii) Working knowledge of English and Hindi/Bhartiya Bhasha (iii) Experience of working in a school (iv) Diploma from National Institution of Sports.

Candidates who fulfill the above eligibility conditions may attend the walk-in-interview with their duly filled in application form in the following format with a recent passport size photograph and original testimonials, proof of age, caste certificate in respect of SC/ST/OBC and produce a set of self attested copies of testimonials for scrutiny one hour before the commencement of the interview.

Please refer to your letter No.F. 2-3/ए/2019/1266 dated 13.07.2019 on the subject cited above and to invite your kind attention towards the recommendation of the Establishment Committee made in its meeting held on 19.01.2011 regarding extension of the appointment of Lecturer on contract basis as produced below:-

"The committee in the overall interest of the students recommended that the faculty/teachers may be engaged on contract basis for a maximum period upto three years against the vacant sanctioned post on a consolidated remuneration of each post. In order to avoid any legal complications, that the person so engaged on contract basis be given a break after one year and a fresh agreement be entered into for next tenure of one year or so. All engagement on contract basis must be as per the eligibility conditions prescribed in the respective Recruitment Rules/UGC Guidelines." The Minutes of 41st Establishment Committee was circulated to all RIEs/NERIE vide Council's letter of even number dated 10.03.2011.

In the light of the aforesaid recommendations of the Establishment Committee, the institute may engage the incumbent against the sanctioned posts as per need.

In future, unnecessary correspondence may be avoided to avoid delay, where rules position/ order exist.
